#### MECHANISM OF ADMINISTRATIVE AND LEGAL REGULATION OF CONTROL OF THE ACTIVITIES OF THE NATIONAL POLICE OF UKRAINE BY THE OFFICE OF PUBLIC PROSECUTOR

Under the mechanism of legal regulation it is considered a set of legal means through which the legal regulation of social relations in the field of administrative law is carried out. Paper states that the issues of the mechanism of administrative and legal regulation in the structure of supervision of the prosecutor’s office for the

activities of the National Police of Ukraine in the legal literature haven't been not researched yet. There was a concept that supervisory proceedings are mainly governed by the rules of criminal procedural law, and the mechanism of such activity lies in the area of the criminal process. It is proved in the article that most of the concepts related to the control and supervision of the prosecutor's office are determined by the norms of administrative law, and the mechanism of administrative-legal regulation has all those components which have been developed by scientists who studied the norms of administrative law.

An attempt was made to determine the mechanism of legal regulation in the area of supervision of the prosecutor's office for the activities of the National Police of Ukraine and to identify its main components. On the basis of this definition, the provisions on the peculiarities of the operation of the abovementioned mechanism in the field of supervision of the prosecutor's office and supervisory activities of the work of the National Police are formulated. These features can be attributed to the fact that all activities of the prosecutor's office in the field of supervision are regulated by separate norms, which can be called the standards of prosecutor's office or prosecutor's law. In addition, these norms are, in most cases, clearly defined and do not allow double interpretation.

On the basis of such analysis, it is proposed to introduce a number of changes to certain normative acts in order to enhance the activity of the prosecutor's office in the field of supervising the work of the National Police.
