ANALYTICAL WORK IN THE REALM OF POLICING IN UKRAINE

The article considers analytical work in the realm of policing in Ukraine as a method of studying the system of organizational measures implemented by the subjects of the analytical work of the police to study and analyze the assessment of information regarding the operational status, structure, level and dynamics of the state of crime, preparation and operational decision-making, management decisions, control and verification of their execution in order to counteract offenses and ensure law and order in the state.

The analytical work is carried out at different levels of police administration, and above all, the development of objective managerial decisions and consists of research into the processes that took place in the field of police activity in the past, the conditions of the present environment and establishes trends in the development of police authorities and is the basis for forecasting and planning. Analytical work in the field of police activity depends on: the scale and importance of the decisions that are made; quantity and character of managed parameters; the duration and frequency of the control cycle, the frequency of the step of regulation; the magnitude and variety of internal and external influences on its implementation; the number and quality of the indicators that characterize the results of the assessment of the work of the police; managerial decision-making by police chief and the setting of new goals and objectives for improvement of the work of the police.

The main types of analytical work in the field of police activity are: analysis of the day (operational analysis), carried out for the organization of ongoing work on ensuring public safety and order, counteraction to the offense, conduction of pre-trial investigation, disclosure of crimes, an effective use of available forces and means by

police authorities; current analysis carried out on the basis of assessment of daily, weekly and monthly information in order to ensure continuous operational management by the police, which allows for adjustments and additions to the relevant work plans, to change the deployment of forces and means; analysis for the reporting period (quarter, half-year, nine months, year), aimed at identification of deviations from the main tendencies of the state of internal security, law and order in the state. During its implementation, the dynamics and structure of crime are analyzed, as well as the reasons for the changes, in conjunction with the assessment of the effectiveness of the work of the police; extraordinary analysis, which should be carried out in case of complicated operational situation, emergencies; problem analysis, which is intended to study specific problems in the organization of crime prevention, domestic security and law and order in the region and the state; analysis over a long period (more than a year) that is conducted to identify the main trends in the development of a criminogenic and operational environment and the development by the police of perspective organizational and managerial measures for the effective provision of public security and order, and the fight against crime.

The author's concept of analytical work has been considered, the subjects of its implementation have been established, and some changes have been proposed to the current legislation and normative legal acts of Ukraine.
