#### FORMATION AND IMPLEMENTATION OF STATE POLICE IN THE FIELD OF INTERNAL AFFAIRS

Paper is devoted to the issues of formation and implementation of state policy in the sphere of internal affairs. It is noted that the Ministry of Internal Affairs of Ukraine, being the central executive body whose activities are directed and coordinated by the Cabinet of Ministers of Ukraine, has become the main body in the system of central executive authorities that ensures the formation of state policy in the following areas: insurance of the protection of human rights and fundamental freedoms, interests of society and state; crime prevention; maintenance of public safety and order; provision of police and administrative services; defence of the state border and protection of sovereign rights of Ukraine; civil defense organizations, preventing emergencies and eliminating their consequences; migration and citizenship. Such central executive authorities as the National Police; the State Border Guard Service; the State Migration Service of Ukraine; the State Emergency Service of Ukraine implement the state policy in the above-mentioned areas. These bodies perform their tasks and functions independently. Such a concept is that the direct management (decision-making) is executed by the heads of the central governments coordinated by the Cabinet of Ministers of Ukraine, and the political representation is under the authority of the Minister of Internal Affairs of Ukraine.

The realities of the presence give the grounds to assert that, on the one hand, despite the exceptional complexity of the socio-political, economic and criminal situation

in the country, the system of the Ministry of Internal Affairs of Ukraine preserves its integrity, being one of the effective tools of state policy in the field of internal security of the state. The Ministry of Internal Affairs has become a civilian office, the powers of the Minister of Internal Affairs of Ukraine on the coordination of the activities of the National Police, National Guard, Migration, Border Guard, Fire and Rescue Services correspond to the construction of the Ministries of Internal Affairs of European countries. On the other hand, the modern system of administration of the Ministry of Internal Affairs will require significant improvement and without prolonging fundamental internal reforms, it will not be able to carry out effectively the functions and tasks assigned to it. At the legislative level, there is a need for an adoption of such bills as: “About Service and Service Centers of the Ministry of Internal Affairs of Ukraine”, “About Private Detective (wanted) Activity”, etc. In addition, changes to the legislation are urgently needed, in particular regarding the introduction of the amendments to the CPC (regarding criminal offenses), the reformation of the criminal bloc, definition of concepts, namely: “law enforcement agencies”; “law and order agencies”; “system of the Ministry of Internal Affairs”; “police service”, “police activity”, “civil order”; “public security”; “public order”; “public security”. It also requires amendments and additions to a number of resolutions of the Cabinet of Ministers of Ukraine and departmental regulations.
