ADMINISTRATIVE LAW ENFORCEMENT PROCEEDINGS

Paper deals with the issues of regulation of executive proceedings by means of administrative law. It is proved that enforcement proceedings are in most cases regulated by administrative norms. However, several aspects of enforcement proceedings are regulated by the norms of other branches of law. The issue of distinguishing a separate branch of law – "executive power" – has been violated, but these aspects require additional research. Some additions to the law on executive proceedings are suggested.

The administrative and legal support for the implementation of enforcement proceedings must meet a number of requirements, without which enforcement proceedings can not be implemented. These requirements include the issue of documents on enforcement proceedings, the timing of enforcement proceedings, the place of enforcement and the composition of enforcement proceedings. Administrative procedures also determine the beginning of enforcement proceedings, the completion of enforcement proceedings and a number of other aspects. Like every administrative proceeding, enforcement proceedings must be well-organized. Any violation that is permitted in the course of enforcement

proceedings in the future may be the subject of an appeal and, accordingly, its result may be revoked. Thus, the purpose of this paper is to identify the main aspects of enforcement proceedings that must be followed in order to implement it at an appropriate level.
