DEFINITION AND CLASSIFICATION OF SUBJECTS OF ADMINISTRATIVE AND LEGAL REGULATION OF SCIENTIFIC AND TECHNICAL ACTIVITIES

Paper deals with the characteristics and classification of subjects of administrative and legal regulation of scientific and technical activities. The classification of subjects of administrative and legal regulation of scientific and technical activity is suggested to be conducted with the appropriate administrative influence exercised in this sphere of public life, namely: general influence of the state on the sphere of scientific and technical activity; branch influence on social relations in relation to scientific and technical activity; influence on information provision of the sphere of scientific and technical activity as an element of general administrative-legal regulation; controlling influence on the scientific and technical sphere as an element of general administrative-legal regulation; law enforcement influence on the sphere of public relations in scientific and technical activity as an element of general administrative-legal regulation; technical regulation of scientific and technical activity as an element of general administrative-legal regulation; influence on the metrological provision of the scientific and technical sphere as an element of general administrative-legal regulation; influence on the financial component of scientific and technical activity as an element of general administrative-legal regulation; influence on intellectual property in the field of scientific and technical activity as an element of general administrative-legal regulation; influence on the ecological component of scientific and technical activity as an element of general administrative-legal regulation; influence on the system of state regulation in the sphere of technology transfer as an element of general administrative-legal regulation of scientific and technical activities; influence on the sphere of international relations on scientific and technical activity as an element of general administrative-legal regulation, etc. In addition, it is determined that subjects of administrative and legal regulation of scientific and technical activities may be classified in more detail on the administrative influence on different branches of this activity, namely: branch influence on the sphere of scientific and technical activity in a certain, relevant field of this activity, such as light industry, machine building, space industry, technical support of agriculture, medical care, etc.; influence on a specific sphere of

scientific and technical activity, as the development of special, military equipment, the creation of objects of defense purposes, objects of special technical means, etc.

Keywords: scientific and technical activities, subjects of administrative and legal regulation, objects of intellectual property, unprofitable state-financed organizations.
