**ANTI-CORRUPTION RESTRICTIONS AFTER THE TERMINATION OF
SERVICE IN THE NATIONAL POLICE OF UKRAINE**

Research article reveals the issues of legal regulation of the application of anti-corruption restrictions to persons who have ceased service in the National Police of Ukraine.

The author has defined anti-corruption restrictions for police officers who have stopped serving in the National Police of Ukraine, as certain prohibitions established by the state for police officers who have stopped serving in the National Police, who have a manifestation of a temporary restriction of their rights and freedoms, in order to minimize the risks of a conflict of interest during the transition a police officer for other work, not related to the performance of the functions of the state or local government, and to protect the interests of the state and civil society.

The author identified specific signs of anti-corruption restrictions: a) these are mandatory rules of conduct for the relevant subjects, temporarily limiting their rights and freedoms; b) they are established by the state, in particular, in the Law of Ukraine "On the prevention of corruption"; c) the form of implementation of these restrictions - passive behavior, that is, refraining from certain actions or failure to perform certain actions prohibited by law; d) unlike all other anti-corruption restrictions, these restrictions apply not to police officers, but to persons dismissing from

police service; e) these restrictions must be valid for a certain period, namely one year from the date of separation from service. Such a relatively short period is the most optimal given the inadmissibility of establishing excessive restrictions for citizens released from state bodies or local self-government bodies. On the other hand, such a period is sufficient to eliminate or significantly weaken the person's ability to use his previous official position in bad faith; f) the purpose of these restrictions is to minimize the risks of a conflict of interest when a police officer is transferred to another job that is not related to the performance of state or local government functions, and to protect the interests of the state and civil society.

A characteristic feature of the Ukrainian model of anti-corruption restrictions for persons who have terminated their civil service, in particular the police service, is that these restrictions may entail certain legal consequences provided for by the current legislation.
