## TOOLS OF ADMINISTRATIVE AND LEGAL SUPPORT OF THE IMPLEMENTATION OF POLITICAL RIGHTS OF CITIZENS OF UKRAINE

Research article analyzes the role and importance of instruments of administrative law in ensuring political rights and freedoms; features of the implementation of political rights through the tools of administrative and legal support.

The content is concretized and the ratio of legal concepts is defined: “instruments” and “forms” of administrative and legal support. It has been substantiated that in order to unify the presented positions it is expedient to give preference to the concept of “tools of public administration” over the forms of public administration.

The classification of tools of public administration in the works of different researchers is given. It has been substantiated that among the instruments of administrative and legal support of political rights the leading place is occupied by normative legal acts and administrative acts.

According to the degree of importance and frequency of use, administrative agreements and plans occupy a less important place. Instead, the actual actions of registration actions, including public associations, political parties, bodies of territorial self-organization of the population, as well as the drawing up of protocols on administrative offenses are important in the system of ensuring and restoring violated political rights and freedoms.

The use of instruments of administrative and legal support is an important element of the system of ensuring and guaranteeing the rights and freedoms of citizens. Among the instruments of administrative and legal support of political rights, normative legal and administrative acts occupy a main place. Administrative agreements and plans are less important in terms of importance and frequency of use. Instead, the actual actions of registration actions, including public associations, political parties, bodies of territorial self organization of the population, as well as the drawing up of protocols on administrative offenses, play an important role in ensuring and restoring violated political rights and freedoms.
