### EXAMINATION OF AN INTEGRITY IN THE USA POLICE: THE REGULATORY ASPECT

Research article examines the integrity of police officers in the United States, discusses the history of development, experience, the procedure for its implementation,

as well as forms of fixation in the legal field of the state. The elements of such an inspection, which are important for the implementation process in the law enforcement agencies of Ukraine, are analyzed. The positive aspects of such verification that can be applied in Ukraine, taking into account the peculiarities of national legislation, are highlighted, and appropriate recommendations are provided. Thus, most often the test of integrity in the United States is conducted by simulating a situation, which purpose is to observe the behavior of a particular person. Integrity testing is the creation of virtual situations or conditions, which purpose is to provoke the person being tested to detect an illegal reaction. By type, integrity testing is targeted and random. A target test is an operational combination that is performed on individuals in order to identify their behavior in a particular situation. During random tests, the inspectors' attention is focused on solving statistically detected corruption tendencies and is focused on pre-determined officers. The integrity review procedure in the United States includes the following: 1) collection of operational data; 2) preparation of an appropriate scenario, which is formed on the basis of previous allegations; 3) inspection of the planned place of inspection; 4) recording of the results of the inspection, saving technical audio and video recordings.

In addition, the elements of such an inspection, which are important for the implementation process in the law enforcement agencies of Ukraine, are analyzed. The positive aspects of such verification that can be applied in Ukraine, taking into account the peculiarities of national legislation, have been highlighted. Thus, it is recommended to conduct two types of integrity checks in Ukraine: targeted and general; taking into account foreign experience to determine the procedure and stages of an application of the modeling method, during which to decide on the admissibility of provocative actions by inspectors.
