THE SPECIFICITIES OF GENDER-BASED VIOLENCE AGAINST WOMEN IN SITUATIONS OF MILITARY AGGRESSION

The article analyzes the specifics of violence in situations of military aggression. The analysis of statistical data of the Uniform State Criminal Offences Report provided by the Office of the Prosecutor General of Ukraine for January and April 2022 on certain articles of the Criminal Code of Ukraine, which establish responsibility for violence against women, was carried out. In the context of increasing military aggression of the Russian Federation against Ukraine, the conclusion is given about each type of criminal offences related to gender-based violence against women.

Author defines the definition of gender-based violence used by international nongovernmental organizations as an umbrella term for any harmful act committed against a person's will and based on socially prescribed (i.e. gendered) differences between men and women. Such acts include acts that cause harm or suffering of a physical, sexual or mental nature, threats of such acts or coercion and other deprivations of liberty.

The study examined which subjects more often commit gender-based violence against women in situations of military aggression, namely, any individuals who have committed FGM even before military aggression, but during military aggression there is more opportunity and imbalance of increasing forces. probability of committing FGM; individuals who control resources (local government officials and even humanitarian workers); armed individuals: military (with military on both sides), bandit groups. Additionally, it has been established that territorially GBV occurs more often at frontline locations, in overcrowded housing (e.g., shelters), at military checkpoints, and in places of forced detention (detention, captivity). In terms of time,

GBV more often occurs at night, after curfew, when military personnel arrive and are stationed in an area with material supplies, as well as during demobilization after the end of a military aggression (this is when risks from intimate partners increase). Measures to prevent gender-based violence against women under martial law are described.
