## CURRENT DIRECTIONS OF SCIENTIFIC DEVELOPMENT AND IMPROVEMENT OF ORGANIZATIONAL AND TACTICAL PRINCIPLES COMBATING ORGANIZED CRIME IN UKRAINE

The article considers the current state of scientific development of problems in combating organized crime by operational units of law enforcement agencies. It is emphasized that in the conditions of military aggression of the Russian Federation against Ukraine and attempts to destroy the Ukrainian state, organized crime poses

a direct threat to national security. The growing number of criminal acts committed by organized criminal groups, the use of organized groups and criminal organizations by foreign intelligence services to destabilize the situation in Ukraine require new approaches to combating organized crime.

The purpose of the study is to consider current areas of further development and improvement of organizational and tactical principles of combating organized crime in Ukraine. To achieve this goal, dialectical, historical-legal, comparative-legal, system-structural, statistical and formal-logical methods were used. According to the results of the study of scientific works, it is established that to date a comprehensive study of the legal and organizational and tactical principles of the National Police operational and investigative activities aimed at combating organized crime in modern conditions, not conducted.

The list of actual directions of further development and improvement of organizational and tactical bases of counteraction to organized crime by operative divisions of law enforcement agencies is offered, namely: organizational and legal bases of counteraction to organized crime in martial law; legal and organizational and tactical features of combating organized crime as a tool used by foreign intelligence services to destabilize the situation in Ukraine; organizational and legal principles of operational support of criminal proceedings in combating organized crime; legal and organizational principles of using criminal analysis in combating organized crime; tactical principles of introducing undercover workers into organized groups and criminal organizations; use of the latest technologies in the detection and investigation of criminal offenses committed by organized criminal groups.
