# LEGAL MECHANISMS FOR RESPONSE TO EMERGENCY SITUATIONS UNDER THE CONDITIONS OF MARITAL STATE IN UKRAINE

The article provides examples of emergency situations of various origins: natural, man-made, social, and military, which arise at the facility, local, regional, and state levels as a result of active military operations. Under certain conditions, the consequences have cross-border distribution and contain components for the formation and

development of large-scale risks and disasters. Such emergency situations also contribute to multifaceted human losses and material damages. Peculiarities of the response of management bodies and civil defense forces to emergency situations caused by military actions have been studied. Legal mechanisms for responding to emergency situations in peacetime and a special period with the involvement of forces and means of functional and territorial subsystems of the unified state system of civil protection are analyzed. As an example, attention is drawn to the role of the functional subsystem of ensuring public safety and order, road safety of the unified state system of civil protection, as a component of the unified state system of civil protection, in the event of emergency situations. It is indicated that during the martial law, the forces of the specified subsystem continue to perform their direct functional (general) duties, as well as, together with the employees of the State Emergency Service of Ukraine, special tasks not typical for everyday activities, but defined by law. The normative legal documents governing the interaction between the National Police of Ukraine and the State Emergency Service of Ukraine in case of emergencies are listed. Considered examples of exceptional emergency situations: natural, man-made, social and military, which have common consequences. Problematic issues have been identified that should be further investigated and studied. Scientific consideration will contribute to the development and implementation of updated approaches, methods and algorithms for actions in the event of emergency situations, the source of which are armed conflicts. Since the consequences of these emergency situations have a wide range of actions. Attention is drawn to violations of human rights and freedoms as a result of emergency situations.
