OF PREVENTING AND COUNTERACTING CORRUPTION**

The article reveals the legal status of the National Police of Ukraine as a subject of preventing and counteracting corruption. The classifier of the subjects of prevention

and counteraction to corruption, according to the results of which it was found that the National Police of Ukraine in the field of prevention and counteraction to corruption refers to the subjects with special powers. The powers of the National Police of Ukraine as a subject of prevention and counteraction to corruption have been defined. Was found that the National Police of Ukraine carries out measures to prevent and counteract corruption at the internal and external levels. On the basis of analysis of the current legislation of Ukraine on the regulation of the activities of the National Police of Ukraine the legal conflict on the application of the definitions of “prevention” and “counteraction” was established.

The article examines the main powers of the Corruption Prevention Department of the National Police of Ukraine and the Department of Internal Security of the National Police of Ukraine in the field of preventing and combating corruption as entities engaged in preventing and combating corruption at the internal level. The author emphasizes that at the external level, prevention and counteraction to corruption are carried out by the pre-trial investigation bodies of the National Police of Ukraine. According to the article, some tasks in the sphere of preventing and combating corruption of the Department of Prevention of Corruption of the National Police of Ukraine and the Department of Internal Security of the National Police of Ukraine are duplicated. The author proposed to use a single structure “prevention and combating corruption” in the norms of the law regulating the powers of the police in the field of prevention and counteracting corruption.
